## A. Executive Director/Board

Tim R. asking the board to consider action related to pass/fail rates. Current ratio is consistent with TEEX testing offerings. Only location that will continue to ask TEEX to help with is the El Paso area. Retesting is 25 questions per section Ops and Awareness

Tim is asking the Board to move away from the 10 awareness questions and 40 operations questions on Hazmat. He has proposed 25 awareness and 25 operations. Allowing 30 minutes per hazmat tests.

Most of it is in the Houston Area and Costal areas. Some drawbacks include the inability to split out certain results such as HazMat A&O on a combined test.

Q&A - Ability to test dozens of folks in a day. Asking hosts to have a minimum of 10 students for testing. Heather travels a lot on the weekends currently taking the bulk of the responsibility on.

Next big goal is to grow testing centers. SFFMA/Heather Looking to grow testing in Junior College areas on a monthly basis and or quarterly basis. Overall very positive report.

C. TEEX Staff Henry Perry is the new liaison with Cert Board and TEEX indicating it will be tough to replace Cary who recently retired.
