- Gordon explained the board changes that took place at the last meeting and asked everyone to take note of new leadership on the board and board members. A lot of driving factors for certifications, regulations and changes in training and compliance. Information sharing and guidance will be from across the state and not so ship channel concentrated. Gordon updated the board in changes with TEEX personnel and curriculum updates as well as Pro Board accreditation.

- Gordon explained we are meeting our minimums and feel we are in good shape. Having more representation from North and West Texas is our only gap.
- Ronnie Procedural review update. All have been reviewed that were revisited. Next step is reviewing the HazMat procedure to try to complete before the next meeting. Ronnie to send out for final approval.
- Gordon currently 6 IMT in the State. Looking for non-manufacturers to fit on the IMT and are they available and deployable. No
 movement at the State level yet. Discussion of why we would have nonindustrial groups involved in TIESB or attached to our procedures.
 Discussion came about from license plates or allowing them to be licensed to be an emergency responder. Guy and Gabe were involved in
 initial discussion from TFS. This was part of Annex F and industrial response.
- Atkinson change wording on "meeting minimum requirements for training" to change the word to and/or with 1910.156 and NFPA. Ronnie made a motion, Mark second and all approved. Change will be made to YTS and procedural language.

- Gordon new classroom building will be finished hopefully in the Summer. Lots of new technology for training classrooms.
 The building will be home of the Texas Fire Fighting Hall of Fame.
- Gordon Recruitment and retention for annual schools is in progress. New classes are being developed based on customer
 ask and need. Initial incident commander, industrial emergencies for municipal responders and others. More work will be
 done to work on industrial/municipal relationships and how to engage both sides.

8. Texas Chemical Council - Atkinson

Occupational Health and Safety Meeting once a quarter. Looking for someone to take on this task. Give an update on what TIESB is
working on and answer questions if there is anything emergency response related. Eric Anderson to attend.

- 9. EMS Mark Garvin
 - Nothing to report
- 10. Industrial Certification Creamer
 - Working on a process to upload certifications to the portal. Hopefully complete in 2 weeks.
 - Application process has been very easy to use.
 - Using the Pro Board website to send over applications works well also.
- 11. Organizational Membership/Marketing
 - Nothing to report. David Wade not in attendance.
- 12. TDEM/TFS/IMT Duncan
 - 3 IMT currently available. One deployed to assist with Deer Park/ Pasadena tornado response. 6 teams in the state. Concerns
 always with MOU/MOA when it comes to a single resource without activating the entire team. Trying to model closer to
 Texas TF 1.
 - IST Incident Support Team a team who will support the event using the state partners to help manage the process with non-responder groups as needed. IMT will help manage the incident, but the IST will make sure the ESF and that nothing is falling through the cracks. More to come.

13. Industrial Fire School

- Gordon Announcement went out this week. Lots of group experience and senior leadership. Some changes will be seen in roles.
 Rescue curriculum will be based on new 1006 changes. Scenario based training will be added. Ron Gilbert from Exxon heading up the rescue. Need to help promote more hazmat training. Specialist classes didn't make last year.
- Elgin IRIS is trying to also do an annual school. Not to compete with TEEX, but some locals do not want to travel or have the means to travel because of budgets.
- Jeff Consider changing this item on the agenda to Industrial training instead of Industrial Fire School. Any vetted program can be brought up at this time. All agreed.
- 14. Vehicle Registration
 - Creamer 178 renewed. 383 unpaid. Some stickers still said 2022 so they had to be resent.
- 15. Firefighter Liability Todd Johnson, Jeff Suggs
 - ESF 4 was reopened, and indemnification added but nothing has been adopted. Industrial members are still not considered
 TIFMAS, or a state resource where protection in a disaster would be granted. Guy Duncan to follow up on ESF 4 and where
 that may be headed at TDEM.
 - State mutual aid allows indemnification if requested as a state asset, however no clear path for industrial companies and civil liabilities.
 - A lot of emphasis on the firefighting foam and PFAS is also a concern for indemnification.
- 16. Board Procedural Documents
 - See above on reviews and approvals.
 - Mark Consider the EMS procedures. There are some absolute languages that need to be reviewed. The YTS says one thing and
 procedures another.
 - Motion to change the procedure to match the YTS and require ICS 100, 200 and 700 as a requirement. Mark made the motion, Ronnie seconded and all approved.
- B. Executive Director's Report Tim Rutland
 - The adoption of the fee decrease has been a positive move. The entire delegation approved the motion. This was a few hundred delegates. One reason for the reduction in fees was to help with increasing industrial certifications. Must be a member for training to count and get the certification. We are still in the early stages of getting the certifications moving.
 - SFFMA Portal is up. The site will be released in sections and pieces. The registration and member dues process is currently online. Hopefully in 2 to 3 weeks the training portion will be up and running, including scheduling of exams. Training based on objectives will be coming and uploading external certificates will be available.
 - Go establish your account if you haven't already done so.
 - Donnie we know the process will take some time to get moving with certification. The SFFMA board appreciates all
 companies that have started the process.
